Ι	All the fire protection arrangements shall be maintained in good condition as seen during inspection. If any lapses found the NOC will be cancelled immediately.		
II	All the escape/ exist routs shall not be kept locked/ blocked or encroached.		
III	All the occupants must know the correct method of operation of the fire fighting system installed.		
IV	Any loss of life or property due to non-functioning of fire safety measures and other installation shall be the responsibility of the management.		
V	All students/ staff members of the intuition shall be trained to operate the fire safety equipments during emergency.		
VI	Addition/ alteration, if any in the building may be obtained with prior permission from this Department.		
VII	Mock Drill should be conducted once in 3 months for initial Two Years. Thereafter, once in every 6 months.		
VIII	It is certified that the Fire Inspection and No Objection Certificate from Fire Prevention Wing, GVMC can't be claimed as right for the Building Regularization.		
IX	The management shall obtain the building permission from the GVMC and this NOC cannot be construed as building permission or regularization of existing building.		
Х	This certificate is valid for TWO YEARS from the data of issue.		

This No Objection Certificate for occupancy clearance is valid for two year from the data of issue of this letter. It is the responsibility of the builder to apply for clearance of NOC, duly remitting the user charges as per G.O. Ms.No.71, Home (Prison-A) department, dated of two months before expiry of this No Objection Certification
